

## **SOVENTIX announces sale of solar park in Italy to psaier.energies**

**January 16, 2018, Brixen / Wesel** – SOVENTIX GmbH, an international project developer of solar power plants, sold its "Benesolar" solar park to psaier.energies GmbH in December 2017. The roof-top system with a capacity of 741 kilowatt peak (kWp) is located in Benevento, an Italian town not far from Naples. The plant went into operation in June 2011 and was operated profitably in the SOVENTIX portfolio until the sale. The proceeds from the sale of the solar park shall be invested in the further international expansion of SOVENTIX.

The development and construction of the solar park was carried out by SOVENTIX. Each year, the approximately 3,800 crystalline solar modules in the rooftop system produce around one gigawatt-hour of electricity. This corresponds to the savings of about 560 tons of CO<sub>2</sub> emissions. The modules were assembled on the roof of a warehouse. The installation area was divided into two photovoltaic systems with 674 and 67 kWp, which together shape the Benesolar project. The rooftop system offers above-average returns with a sunny yield of 1,328 kWh / kWp and the fixed feed-in revenues in accordance with the Italian Conto Energia II tariff.

"The project in Benevento was very successful. We were able to fully utilize our expertise in the development, planning and construction of the plant and have generated attractive income from the operation of the plant over the last few years. We are pleased that we have found a renowned buyer for this project with psaier.energies," says Thorsten Preugschas, CEO of SOVENTIX GmbH.

Eugen Psai, CEO of psaier.energies GmbH, comments in a favourable light on the signing of the contract: "With the purchase of the Benesolar plant in the center of Italy, we further strengthen the portfolio in our core market. This is an important step in optimizing our plant portfolio." The Benesolar project was the last existing plant of SOVENTIX GmbH in Italy, after nine other plants from an existing portfolio were successfully sold in recent years. In particular, projects in South Africa, the Dominican Republic and Chile are currently being driven forward. In these markets, there are optimal conditions for the expansion of solar energy even without state subsidies.
